2 3 10A NCAC 43G .0108 **ADMINISTRATION** 4 The Department of Health and Human Services shall administer the statewide early intervention program under 5 Federal law, Part C of the Individuals with Disabilities Act (IDEA). 6 7 History Note: Authority G.S. 130A-126; 8 10A NCAC 43G .0110 is proposed for readoption without substantive\changes as follows: 9 P10A NCAC 43G .0110 ELIGIBILITY 10 (a) Children from birth to age three are eligible for early intervention services under the provisions of this 11 subchapter and under Part C of the Individuals with Disabilities Education Act (IDEA) if they have been determined 12 by the Children's Developmental Services Agency to meet the criteria of one of the two following categories: 13 (1) developmental delay; or 14 (2) established conditions. 15 (b) Developmental Delay. 16 A child is considered to have developmental delay if the child's development is delayed in one or (1) 17 more of the following areas: 18 (A) Cognitive Development; 19 (B) Physical Development, including fine and gross motor function; 20 (C) Communication Development; 21 (D) Social-Emotional Development; or 22 (E) Adaptive Development. 23 (2) The specific level of delay shall be: 24 (A) documented by scores of 2.0 standard deviations below the mean of the composite score 25 (total test score) on standardized tests in at least one of the above areas of development; 26 or 27 (B) documented by a 30 percent delay on instruments which determine scores in months in at 28 least one of the above areas of development, or 29 (C) documented by scores of 1.5 standard deviations below the mean of the composite score 30 (total test score) on standardized tests in at least two of the above areas of development, 31 or 32 (D) documented by a 25 percent delay on instruments which determine scores in months in at 33 least two of the above areas of development. 34 (c) Established Conditions. A child is considered to have an established condition if the child has a diagnosed 35 physical or mental condition which has a high probability of resulting in developmental delay. Diagnosis may be 36 made by Children's Developmental Services Agency staff or the child's physician. Specific conditions through 37 which a child shall be deemed eligible in the established conditions category are as follows:

16	(8)	Neonatal Conditions and Associated Complications. These are children diagnosed with one or	
17		more of t	the following neonatal diseases or disorders:
18		(A)	Gestational age less than 27 weeks or birth weight less than 1000 grams;
19		(B)	Neonatal encephalopathy with neurological abnormality persisting at discharge from the
20			neonatal intensive care unit.
21		(C)	Moderate to Severe Ventricular Enlargement at discharge from the neonatal intensive
22			care unit or a ventriculoperitoneal shunt;
23		(D)	Neonatal seizures, stroke, meningitis, encephalitis, porencephaly, or holoprosencephaly;
24		(E)	Bronchopulmonary Dysplasia requiring supplemental oxygen at discharge from the
